

FIM RALLY **SUPPLEMENTARY REGULATIONS**

Reg. 1

The 2010 FIM Rally is organised by K.A.M.C. Herentals

On behalf of the Fédération Internationale de Motocyclisme (FIM) and the Commission for Leisure Motorcycling (CML), the event will be held from 22 to 24 June 2010 according to the FIM Code for Touristic Gatherings (hereafter known as CTG) – FIM Rally section; to the rules of the FIM, to these Supplementary Regulations and to the FIM Environmental Code.

Reg. 1.2 Executive Committee

The first meeting of the Executive Committee will be held on 21 June 2010 at 15.00 at the Bloso center Vorselaarsebaan 60 2200 Herentals
Subsequent meetings will be fixed by the Executive Committee.

Reg. 2 Participation in the Rally

According to the CTG (Rally: Arts. 2 & 4).

Reg. 3 Entries

Reg. 3.1 - Individual entries will be made on the form made available for this purpose (or the duplicate) which will be delivered to the FMNs by the organiser (CTG Rally Art. 5).

The FMNs will return the entry forms to the organiser after verification (see address in Reg.1.1).

Reg. 3.2 - The FMNs will also add a summary list (excel sheet(s) containing the following information:

- Names of participants
- The sum paid for the entry fees and accommodation (hotel and camping)
- The names and addresses of the participants' motorcycle clubs
- The distance from the headquarters of the clubs to the Rally centre
- The name, licence number and e-mail address of the National Delegate(s)

Reg. 4 Entry Fee

The entry fee is fixed by the Federation of the participant. This is composed of the organiser's fee of € 190.00 per person, plus any administrative expenses which may be added by the FMN. The amount is fixed in Euros (€).

Children between the ages of 8 and 12 will pay 50% of the adult entrance fee. Children under the age of 8 will be admitted free of charge.

The entry fee will be paid in full (100%) by the FMNs of the participants before 31 March 2010 to the following account:

All payments will be made in Euros (€). The transfer costs are to be paid by the expeditor.

Reg. 5 Closing date for entries

The deadline for the entries and the booking of the accommodation is 31 March 2010

Reg. 6 Gifts, souvenirs and services for the participants

Every participant who has paid the registration fee will receive:
A bag containing souvenir gift(s) and a medal or plaque
Excursion in the vicinity
An entertainment programme

3 evening meals and 2 picnic(s) (CTG Rally Art. 6).

Reg. 7 Accommodation

- 100% of the campsite booking fee will be paid with the registration.
- 100% of the hotel booking fee will be paid when the hotel is booked.
- **The hotel booking will only be accepted after receipt of payment.**

The camping bookings will be made on the "accommodation" booking form. (For hotel list and bookings see on the site www.fimrally2010.eu)

The amounts due for the camping will be paid at the same time as the registration fee, i.e. before 31 March 2010 to the bank account quoted in Reg. 4.

Campsite: € 15.00 per person per night (breakfast included)

All payments will be in Euros (€) and will cover the transfer costs.

Reg. 8 Optional Benefits

- a) 19, 20 and 21 June 2010 – campsite with breakfast included € 15.00 per person reserved in advance.
- b) 21 June 2010 Excursion to Bobbejaanland Family Park at € 25.00 per person.

Bookings for these optional excursions must be made at the same time as the registration on the special form provided. These trips are also to be paid for at the same time as the entry.

Reg. 9 Welcome Centre

The Welcome Centre will be open on: 19 June 2010 from 14.00 to 20.00

On arrival day, each participant will receive information concerning the gathering place from which each national team will pass by the Arrival Control.

The entry papers and vehicles of the participants will be checked at the Welcome Centre upon arrival. The FIM Meritum and Co-Meritum stamps will also be distributed at this time. Participants will receive a "classification card" similar to their ID card which **MUST** be handed over at the Arrival Control.

Reg. 10 Arrival Control

The Arrival Control will be operational on 22 June 2010 from 09:30 to 17:00 at Grote Markt Herentals

In order to be classified, participants must hand over the “classification card” distributed earlier at the Welcome Centre. Neither copies nor the original entry forms will be accepted or counted for the classification.

Reg. 11 Closed Park (Parc Fermé)

After the control, the motorbikes will stay in the Closed Park until the last nation has passed by the Arrival Control and the final national hymn has been played. Participants may leave the Parc Fermé after this time. However, the Parc Fermé will remain secured until 16:00.

Reg. 12 Results and Classification

According to the CTG (Rally Art.15).

Reg. 13 Disqualification

Participants shall be officially disqualified at the discretion of the Executive Committee if necessary.

Reg. 14 Prize-Giving Ceremony

According to the CTG (Rally Art. 25). This will take place on the evening of 24 June 2010

However, the Inter-Club prizes will be awarded on the second evening.

Reg. 15 National Delegates

Each participating FMN has the right to nominate one delegate holder of a Tourism Steward's licence. The nomination shall be made in writing to the organiser at least 15 days before the event. (See Art. 18.7 - Instructions to the Organisers and Participants of a FIM Classic Touristic Gathering – Category A.) See also Reg. 3.2 of these SR.

Reg. 16 Cancellation of event

According to the CTG (Rally Art.9).

The organiser can cancel the event:

- If, at the closing date, the number of entries is below 1000
- In the case of absolute necessity

In the case of cancellation of the event, the participants who transmitted their entry forms before the closing entry date will be notified.

Reg. 17 General

Comments at the discretion of the organiser.

Reg. 18 Liability of the Authorities, Organisers and Participants

According to the CTG (Rally Art. 14) and Art. 19 (Touristic Gatherings of Category A).

Reg. 19 Rider Conduct and protection of the environment

Participants of the FIM Rally are motorcyclist ambassadors of their country and are expected to consider other road users. (CTG Rally Art.3)

Recommendations to Road Users:

- a) Individual motorcyclists should develop riding habits to ensure full integration with other types of road users
- b) Ride safely and avoid aggressive and competitive riding.
- c) Save petrol and reduce pollution by avoiding unnecessary idling of engines.
- d) Ride politely and limit noise pollution by using your horn only in an emergency
- e) Noise annoyance. Use a standard or another quiet exhaust system and keep audio systems at a low level.
- f) Use only routes which are open to motorcyclists.
- g) Ride like a professional by riding at a quiet and unobtrusive pace when riding in groups.
- h) Respect nature by not travelling on paths which risk being damaged beyond a point of natural recovery.
- i) Protect wildlife and its natural habitat by riding intelligently.
- j) Ensure that your used oil, tyres, batteries, and other recyclable items are properly recycled or collected.

- k) Encourage a rational use of fuel and space economy by using motorcycles instead of driving automobiles.
- l) Remember that our cities and our roads are not circuits.
